**PRICES EFFECTIVE JULY 1, 2023, AND SUBJECT TO CHANGE WITHOUT NOTICE**

The goods and services shown in this price list are those we can provide to the families we serve. You may choose only those items you desire. HOWEVER, ANY FUNERAL ARRANGEMENTS YOU SELECT WILL INCLUDE A CHARGE FOR OUR BASIC SERVICES AND OVERHEAD. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Payment in full is required 72 hours prior to furnishing of any merchandise, ceremonies or disposition. Acceptable forms of payment are cash, cashier's check, VISA, MasterCard, American Express and incontestable/assignable life insurance policies. There will be a 6% processing fee on all life insurance policies added to the Cash Advance Section of your Statement of Funeral Goods and Services selected. We do not accept estate claims. We will add 3% to the total when credit cards are used. This fee will be added to the Cash Advance section of your Statement of Funeral Goods and Services selected.

CALIFORNIA STATE TAX WILL BE ADDED TO ALL TAXABLE ITEMS. This list does not include prices for certain items that you may ask us to buy for you; such as, but not limited to, outside cemetery or crematory services, flowers, motorcycle escorts for outside processions, and newspaper notices. The charge for these items will be shown on your bill or the statement describing the funeral goods and services you selected. We charged you for our service, for placement of newspaper notices, ordering funeral escorts, providing limousine transportation and placement of floral orders, including cost.

**PROFESSIONAL SERVICES**

**SERVICES OF THE FUNERAL DIRECTOR AND STAFF** ..... \$2095.00

Our service charge includes consultation with the family, clerical and administrative services, preparation of the death certificate and filing of necessary permits, and coordinating the details with the cemetery, crematory, and other parties responsible for the arrangements made. Also, a percentage of this fee is necessary to cover a proportionate share of our established overhead costs such as licenses, Insurance, Indirect taxes (does not include sales tax on items in the merchandise category), maintenance of facilities and equipment, utilities and a host of other cost related to being in business to serve the public. This fee for our basic services and overhead will be added to the total cost of the funeral (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving of remains)

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want to embalm, you have the right to choose an arrangement that does not require it, such as direct cremation or immediate burial. If embalming is declined and the final disposition of the deceased is not completed within 8 hours from the time of death, we require refrigeration.

Transfer of remains to our funeral home (within a 20-mile radius), embalming, preparation of the death certificate and filing of necessary permits, services of funeral director and staff, coordination with other funeral home (mortuary), transportation of remains in an alternate vehicle to a common carrier, without ceremony.

**RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME (MORTUARY) ..... \$1350.00**

Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; care of remains; transportation of remains to funeral home.

**DIRECT CREMATION ..... from \$1595.00**

Our charge, excluding the actual cremation cost itself, for a cremation without ceremony includes adjusted "Basic Services and Facilities," "Transfer," "Refrigeration," "delivery of Remains to crematory," "retrieval of Cremains from crematory," and a "plastic temporary urn." Cremation cannot take place until a death certificate is secured and filed and a burial permit secured. Embalming is not required.

Cremation will be scheduled at Harrison-Ross' convenience. These charges do not include scattering at sea, or other disposition or memorialization after the cremation, urn, etc. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).

The containers we specify are heavy cardboard (fiberboard).

You may also choose a casket for use in direct cremation; a complete list of casket prices is available.

Disposition by burial without formal viewing, visitation, or ceremony with the body present includes "Basic Services and Facilities," "Transfer," "Refrigeration" and "Utility Vehicle" to the local cemetery. Burial cannot take place until a death certificate is secured and filed and a burial permit secured. Burial will be scheduled at Harrison-Ross' convenience. Casket, burial permit, cemetery charges such as property, interment and recording charges, outer burial container, memorial tablet, etc. are not included. Embalming is not required.
